### COMMUNIQUE

Further to the communiqué dated 11 October 2023, the board of directors (the “**Board**”) of ENL Limited (the “**Company**”) is pleased to inform the shareholders and the public in general that (i) the Listing Executive Committee of the Stock Exchange of Mauritius Ltd (the “**SEM**”) has, on 27 October 2023, approved the offer for subscription and listing of secured fixed rate notes and secured floating rate notes for an aggregate nominal amount of up to MUR 2,500,000,000 (the “**Notes**”) on the Official Market of the SEM, and (ii) the Financial Services Commission has, on 26 October 2023, also approved the registration of the prospectus pertaining to the Notes, deemed to be the listing particulars (the “**Prospectus**”).
