Further to the Cautionary Announcement and the Notice dated 07th August 2019 and 19th August 2019 respectively, regarding the proposed amalgamation of Margarine Industries Limited (“MIL”) with and into Quality Beverages Limited (“QBL”) under Sections 245 and 246 of the Companies Act 2001 (the “Amalgamation”), the Boards of Directors of QBL and MIL are pleased to inform their Shareholders and the public in general that, following a Special Meeting of QBL and MIL held on 06th September 2019 (the “Meetings”), the Shareholders (present and/or represented) have, by way of special resolution, unanimously approved the amalgamation proposal (the “Amalgamation Proposal”) with respect to the proposed amalgamation of MIL with and into QBL.

The shares of MIL will be cancelled and QBL will issue to the Shareholders of MIL 48 new QBL ordinary shares for every one (1) of ordinary share of MIL.

The completion of the Amalgamation Proposal is expected to occur on 01st October 2019 (the “Effective Date”).

Should the Amalgamation be completed on the Effective Date, the calendar for Amalgamation procedure shall be as follows:

15 October 2019	Subsequent admission of the new ordinary shares on the DEM
15 October 2019	First trading day of the Ordinary Shares of the Amalgamated Company on the DEM
